

# Parking Security Requirements (PSR) Certification



## What are the Parking Security Requirements (PSR)?

Parking Security Requirements (PSR) have been developed in order to prevent product theft and other crimes occurring to trucks carrying various products, due to unsecured parking areas. The aim of PSRs is to establish minimum acceptable security standards and the ways that they can be upheld.

### Why an PSR standard for Secure Truck Parking Areas?

Up to 75% of all cargo crimes recorded by the Transported Asset Protection Association (TAPA) involve attacks on trucks while parked at unsecured parking locations.

The main reasons are:

- Increase in theft incidents involving parked trucks,
- Need for secure parking locations,
- Lack of a single platform that enables effective route planning, taking into account known incidents and secure parking

### Parking Security Requirements (PSR) Areas of Interest

The Parking Security Requirements (PSR) represent minimum standards specifically for secure parking places used by vehicles intended for the movement of goods by road.

TAPA PSR 2023 Security Standard / Backbone of the PSR standards:



- Perimeter and Entry / Exit Points:
  - Physical Security, CCTV, Lighting, Documented Procedures
- Internal Parking Area:
  - Physical Security, Lighting, Documented Procedures
- PPO Security Management, Staffing, Training and Security Practice:
  - Management Commitment, On-Site Security Staffing, Training, Security Practice, Workforce Integrity- Hiring, Screening and Termination of Employees and Contractors / TAS workers (as allowed by Local Law)
- Driver Comfort Services and Facilities

## 4 PSR Security Levels

Four classification levels are specified in the PSR:

- PSR Level 1 = highest security protection with a formal Certification
- PSR Level 2 = mid-level security protection with a formal Certification
- PSR Level 3 = lowest security protection with a formal Certification
- PSR Partnership Declaration. Minimum entry level not requiring a formal Certification
